
Government of Kerala has earmarked a provision under State Plan 2022-23 for conversion of homestead wells into protected sustainable drinking water sources. Kerala Rural Water Supply and Sanitation Agency (KRWSA) is entrusted to implement this State Plan Scheme through participating Grama Panchayaths/Beneficiaries. Vide ref.1 cited revised guidelines, duties and responsibilities of various stake holders such as KRWSA, GP, BG, SLEC and GPLAC for the implementation of Plan Schemes 2022-23 onwards has been issued. Proposals for conversion of homestead open wells into Protected, Sanitized wells diameter up to 2m and up to 6m with recharge pit under the jurisdiction of RPMU Kannur has been submitted to Government and Administrative Sanction received vide ref.2 cited.

The estimate for conversion of 177 Nos. of homestead open wells into Protected, Sanitized wells diameter up to 2m and up to 6m with recharge pit in Kinanoor Karinthalam GP in Kasaragod and Kavilampara, Puduppady, Omassery, Nochad, Thuneri and Maruthomkara GPs in Kozhikkode District been prepared and Technical Sanction issued by KRWSA for Rs.1,33,30,000/- vide ref.3 cited. E-Tenders were invited for the above said work on 14/11/2022 with last date on 28/11/2022 and tender opening on 30/11/2022. Approved PAC of the work is Rs.1,22,89,713/- with Completion Period of 3 months and Defect Liability Period of 12 months. Since no sufficient bids received on first call, retenders invited on 06/12/2022 with last date on 17/12/2022 and tender opening on 20/12/2022. One bid received and the work was awarded to the L1 bidder Sri.Ronimon Mathew, PW-Irrigation Contractor-B, Manakkadavu P.O., Kannur District - 670571 for an agreed PAC of Rs.1,06,19,539/- (Rupees One crore

six lakh nineteen thousand five hundred and thirty nine only) which is 2.39% below the tendered PAC. Work agreement was executed on 02/02/2023 vide ref.4 cited and the contractor submitted Performance Guarantee for Rs.3,18,600/- in the form of Treasury Fixed Deposit (TFD No.JL1432758) with due date on 01/02/2025 and Additional Performance Guarantee for Rs.83,000/- in the form of Treasury Fixed Deposit (TFD No.JL1432757) with due date on 31/05/2023.

Vide ref.5 cited, Sri.Ronimon Mathew, Contractor has requested to release EMD amount. As per tender condition 8.12.1 the EMD deposited by the tenderer shall be released as soon as the security amount of the above is deposited. Since the Contractor had executed work agreement and submitted Performance Guarantee, the Earnest Money Deposit of Rs.50,000/- (Rupees Fifty thousand only) is hereby released to Sri.Ronimon Mathew, Contractor vide Cheque No...536253..... dated 02.06.2023. of SBI, Kannur Civil Station Branch (through e-FT to Account No.125003213363 of **Canara Bank, Taliparamba Branch (IFSC:CNRB0002506)**). The receipt of the amount is to be acknowledged.
